All players need to be registered and a member of good standing to participate in any Strait Richmond Minor Hockey Association (SRMHA) activities. To be in good standing, any outstanding fees from the previous season must be paid in full prior to registration being accepted for the player or family members. If a player is not in good standing, then the previous year's registration and the current year's registration must be paid in full prior to the player being allowed to participate in on-ice activities.

Strait Richmond Minor Hockey Association (SRMHA) will hold online registration via GrayJay Pay. An early bird registration will take place for approximately 4 weeks beginning the middle of July to the middle of August. After this date, registration fees will increase by twenty-five dollars (\$25). Any registrations submitted after the closing date of October 1, will be subject to a fifty dollar (\$50) late fee.

Registration dates are subject to change. Registration fees will be reviewed by the Board of Directors prior to each hockey season.

Registration Fees are subject to a \$5 non-refundable 3rd party fee.

Current registration fees, including insurance are as follows:

Discounts for multi-player families are only applied to players that are returning and must be all playing under Strait Richmond Minor Hockey.

GrayJay Pay gives you the option to pay via credit card or offline payments. All transaction or processing fees charged by the payment merchant are the responsibility of the payee and are non-refundable.

Families are given the option of making a single payment or two equal payments for registration fees. Full registration fees will be due on October 15. If using the two equal payment option, the first half of fees (50%) will be due on October 15 and the final payment due on December 1. If payment is not received in full on December 1, the player will not be permitted on the ice until such time as full payment is received or payment arrangements have been approved by SRMHA.
